RESOLUTION APPROVING BALLOT LANGUAGE FOR CHARTER AMENDMENT TO SECTION 4.2 OF CHAPTER IV OF THE EAST TAWAS CITY CHARTER REGARDING COMPENSATION OF THE MAYOR AND COUNCIL MEMBERS

At a regular meeting of the East Tawas City Council held on the 7th day of February, 2022 at 7:00 p.m. in the Council Chambers of the East Tawas City Hall, 760 Newman Street, East Tawas, Michigan, the following preamble and resolution were offered by Council member Baker and seconded by Council member McMurray.

WHEREAS, Section 4.2 of Chapter IV of the Charter of the City of East Tawas currently provides that the compensation of the Mayor and Council members be established by Ordinance submitted to a vote of the register electors, reading as follows:

Sec. 4.2. - Compensation of councilmen.

The mayor and councilmen shall receive a salary the sum of twenty-five dollars (\$25.00) per meeting for each regular and special meeting which they attend, to a maximum of thirty (30) paid meetings in any one (1) fiscal year. The mayor shall receive five hundred dollars (\$500.00) extra per year. The mayor and councilmen may, upon order of the council, also be paid any necessary bona fide expenses incurred in the service of the city as are authorized and itemized.

Hereafter, the council may determine the annual salary of councilmembers by ordinance, but no ordinance increasing such salary shall become effective until the date of commencement of the terms of councilmembers elected at the next regular election, which is more than six (6) months after the adoption of such ordinance. It is further provided that at the next such regular election there shall be submitted to a vote of the registered electors the following question:

WHEREAS, the City Council of the City of East Tawas, pursuant to the authority granted by Public Act 279 of 1909, as amended, has determined that it would be in the best interests of the City and would promote good and efficient government to amend said Section of the Charter to provide that the compensation of the Mayor and Council members be established by Resolution following a Public Hearing, and to read as follows:

Section 4.2 – Compensation of Council members

The City Council may determine the annual salary of Council members and the Mayor by resolution following a Public Hearing on this matter being held prior to the adoption of the resolution to increase such compensation. No such resolution increasing such salary shall become effective until the date of commencement of the terms of Council members or Mayor elected at the next regular election provided that such election follows the adoption of such resolution by at least six months. No reduction of the annual salary of a Council member or Mayor shall be imposed during the term or office of such Council member or Mayor. Council members and the Mayor shall receive their actual and necessary expenses incurred in the performance of their duties of office.

WHEREAS, the City of East Tawas would be allowed to sell those properties if approved by the electors of the City, at the discretion of the City Council and in the best interests of the City, and establish certain requirements upon the sale and development of those properties; and

WHEREAS, the property information will be available to the public for review prior to the November 8, 2022 General Election as well as the ballot language.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of East Tawas, Iosco County, approves the following ballot language and proposal, and directs the Clerk to submit this proposal to be place on the November 8, 2022, General Election ballot:
